Protection from the unknown

If you die without an up-to-date will, divvying up assets – and the custody of minor children – can fall to the mercy of your state's laws. Or if you become incapacitated and are unable to express your wishes, your loved ones may have to make some difficult decisions.

By accessing ARAG's **free** online services, you can draft a:

- **Will** – Specifies what happens to your property when you die and who executes your estate. Also lets you name a guardian for your minor children.
- **Living will** – Informs health care providers and your family about your desires for medical treatment if you are unable to speak for yourself.
- **Healthcare power of attorney** – Grants someone permission to make medical decisions in case you can't make them yourself.
- **Financial power of attorney** – Grants someone permission to make financial decisions in case you can't make them yourself.
